SCDOT's Local Government Services Office

- Established December 2021, the office consolidates various financial and administrative management activities associated with local governments under one roof.
- The following offices and program areas fall under the guidance of the Local Government Services
 Office:
 - "C" Program
 - Earmarks
 - Financial Participation Agreements
 - Grants (Internal and External Coordination)
 - Local Public Agency (LPA) Program
 - Scenic Byways
 - Transportation Alternatives Set-Aside Program (TAP)



"C" Program


- The "C" Program is a partnership between SCDOT and the counties to fund local transportation projects, and improve state and county roads and city streets.
- County Transportation Committees (CTCs)
 (primarily appointed by legislative delegation)
 select and approve projects.
- "C" Funds come from 3.99 cents of the gas tax and one-time special appropriations from the General Assembly.





"C" Program Project Eligibility

- Projects selected by CTC
- Transportation project
 - On public property
 - Accessible to the public
 - Resurfacing projects
 - Turn lanes
 - Engineer/Design work
 - Sidewalks
 - Lighting
 - Signage
 - Dedication
 - Speed Control



Infrastructure Investment and Jobs Act (IIJA)



- IIJA authorizes approximately \$1.2T in surface transportation, rail, transit, water/sewer, and broadband.
- Discretionary grant programs are now available to eligible local entities in addition to states.

- LGS oversees IIJA grants activities by
 - Seeking and applying for grant opportunities on behalf of SCDOT, and
 - Coordinating with local entities submitting grants

SS4A Grant ProgramSafe Streets and Roads for All

- The Bipartisan Infrastructure Law (BIL) established the new Safe Streets and Roads for All (SS4A) discretionary program, with \$5 billion in appropriated funds over 5 years, 2022-2026.
- The SS4A program funds regional, local, and Tribal initiatives through grants to prevent roadway deaths and serious injuries.
- The fiscal year (FY) 2023 Notice of Funding Opportunity (NOFO) for Safe Streets and Roads for All grants closed on July 10, 2023.
 - Planning and Demonstration Grant award decisions are expected to be announced in October 2023
 - Implementation Grant award decisions are expected to be announced in **December 2023**.
- The FY24 Notice of Funding Opportunity (NOFO) for SS4A is expected to open in Spring 2024.



SS4A Grant Program

 - raised crosswalks and medians
 - pedestrian refuge islands
 - sign improvements
 - Bicycle and Pedestrian Safety Improvements to Improve Equity Countywide in Contra Costa County CA
 - enhancing bicycle and pedestrian signing and marking
 - installing loop detection upgrades for bicycles at traffic signals
 - ADA-comliant curb ramps
 - SS4A Implementation Grant to Advance Engineering and Construction of Providence, RI's Urban Trail Network
 - Safe and Equitable Access to Montgomery Parks
 - Safety of Trail Crossing
 - Educational Programs for Pedestrians and Cyclists

How Will SCDOT Work with Locals Seeking Grants?

- Locals should be prepared to independently undertake the following items if they are pursuing grants:
 - Seek grant opportunities and prepare all grant applications in their entirety.
 - Enter into grant agreements with the relevant federal funding agency.
 - Manage all aspects of the project including PE, ROW, and construction.*
 - Assume all financial risk, including any overruns.
 - Enter into a maintenance agreement with any improvements above SCDOT's maintenance standard.

*To assist local governments, SCDOT is establishing a qualified list of On-Call consultants to provide local governments assistance with program management support for awarded grants. Usage of the list is <u>not</u> mandatory.



GRANTS ACTIVITIES



The Infrastructure Investment and Jobs Act (IIJA) authorizes approximately \$1.2T in funding surface transportation, rail, transit, water/sewer, and broadband, including \$550B in new funding. It reauthorizes surface transportation authority until 2026, which is important for SCDOT's large multi-year projects like Carolina Crossroads (i.e., "Malfunction Junction"). IIJA also creates new programs for carbon reduction, resiliency, bridges, and electric vehicle (EV) charging infrastructure.

SCDOT-Sponsored Discretionary Grants

IIJA established numerous discretionary grant programs totaling approximately \$100B for state and local governments. SCDOT intends to pursue grants that advance its priorities in the 10-Year Plan, including pavements, bridges, safety, and interstate capacity; we will not focus on grant opportunities that do not align with our priorities.

The Office of Local Government Services will oversee SCDOT's IIJA grants process, from seeking grant opportunities, to application development, to submittal. SCDOT is prepared to manage all awarded grants for which we apply.

Local Governments and Other Political Subdivisions Seeking Grants

What should local entities be prepared to do if seeking grants?

- Independently seek grant opportunities and prepare all grant applications in their entirety.
- Enter into grant agreements with the relevant federal funding agency.

What should local entities be prepared to do if seeking grants on the State Highway System?

If a local entity pursues a grant for a project on the State Highway System, it should provide notice to the Office of Local Government Services (IIJAGrants@scdot.org) at least 30 days before the grant application is due. The minimum required information is listed below.







Small Urban	5,000 to 49,999	\$1,400,000
Small Urban	50,000 to 200,000	\$5,900,000



Eligible TAP Applicants

- Local governments
- Schools/school districts
- Eligible entities within a TMA's boundaries (Entities <u>MUST FIRST</u> apply to the TMA for TAP funds)





Examples of Eligible TAP Activities

- Sidewalks/Multi-use Paths/Trails
- Bike Lanes
- Bike/Pedestrian crossing improvements





Examples of Non-Eligible Activities

- Recreational Multi-use Paths/Trails
 - Purely recreational projects will be referred to SCPRT's Recreational Trails Program (RTP)
- Routine maintenance and operations
- Property acquisition for parking lots





- TAP is a federal reimbursement grant program
 - 80% Federal
 - 20% Local Match*
 - Local Transportation Sales Tax, CTC, Property Taxes
 - Cash only No in-kind matches
 - Must have match in hand before project can start





^{*}Exemptions may apply

IIJA requires prioritization of project location and impact in high-need

areas

SCDOT addresses this by using SC Department of Revenue's County Tiers...

Phased Awards to Prevent Lapse

- Ex: \$1M for design, ROW acquisition, construction
- Phase I: \$200k for design and ROW;
 Phase II: \$800k construction
- Minimum Project \$500,000
 (\$400,000 TAP + \$100,000 match)
- No Project Cap
 (But limited by TAP fund availability)
