South Carolina Economy

Total nonfarm employment in South Carolina grew in February and March, adding 19,400 and 16,400 jobs, respectively. South Carolina has recovered 76 percent of the nonfarm jobs lost since COVID-19 impacted the state. Employment in the Leisure and Hospitality and Other Services sectors remains notably below pre-pandemic levels.

General Fund Revenue

April revenues reflected abnormally high growth for the month. Collections for April last year were low due to decreased sales as a result of business closures and the tax filing extensions instituted at the start of the pandemic. Last year's filing delays combined with low sales resulted in exceptionally high growth rates for this month. Revenues grew 99.1 percent for April compared to the prior year, resulting in a year-to-date General Fund revenue increase of 15.1 percent for FY 2020-21. Total collections are currently \$1,103.8 million higher than last fiscal year with collections being \$421.8 million ahead of expectations. Additional monthly abnormalities are expected throughout the rest of the fiscal year due to both the filing extensions allowed last year for income, sales, and other taxes and significantly decreased sales as a result of business closures.

Revenue Categories

Sales Tax

- Sales tax revenue grew 72.7 percent in April 2021 compared to April 2020, and year-to-date collections are 14.2 percent above last year. April 2020 collections were heavily impacted by business closures resulting from COVID-19 and delays in submission of receipts due to the filing extension to June 1.
- Collections are currently running \$55.6 million ahead of the forecast.

- Changes in consumer behavior as a result of COVID-19 continue. Consumers have maintained higher spending on taxable goods and lower spending on non-taxable services since March 2020. Overall, total consumer spending in South Carolina was up 19.2 percent as of April 4, 2021 when compared to January 2020, driven largely by an increase in spending on retail of 33.1 percent and on restaurants and hotels of 12.2 percent. However, spending on entertainment and recreation continued to be down 36.3 percent relative to January 2020¹.
- Additional direct economic stimulus payments following the passage of the federal *American Rescue Plan Act of 2021* are driving sales tax revenue up as consumers' disposable income increases.

Individual Income Tax

- Individual Income tax revenue totaled \$420.8 million in April 2021 compared to \$238.5 million in April 2020. This irregular amount of growth over last year is largely because filing was delayed to July 15th last year. While, this year's filing extension to May 17th has sped up returns compared to last year, final tax filing season results will not be available until next month.
- Fiscal year-to-date Individual Income tax growth is up from 9.4 percent in March to 13.6 percent growth in April. However, as income tax returns are processed over the upcoming months, we expect this growth will decrease.
- Refunds are projected to increase by 16.8 percent over the full fiscal year due to increased unemployment following business closures in 2020 combined with the estimated \$147 million in last year's delayed refunds processed at the beginning of this fiscal year.
- Withholdings grew by \$54.3 million in April 2021 compared to April 2020, increasing fiscal year-to-date growth to 6.6 percent.
- Non-Withholdings collections totaled \$264.7 million in April 2021 compared to \$92.7 million in April 2020. Fiscal year-to-date growth reached 35 percent in April again due to filing delays.

Corporate Income and License Tax

- Corporate Income tax revenue for the month reached a record high of \$204.9 million, \$176.5 million higher than last year due to filing delays in 2020. Corporate License tax is up \$3.4 million for the month.
- Fiscal year-to-date Corporate Income tax collections are \$104.4 million ahead of expectations, and Corporate License tax is ahead by \$7.8 million.

• Corporate Income tax revenue is projected to increase by 10.1 percent over the full fiscal year, and Corporate License tax is projected to increase by 5.4 percent. Currently, these categories are up 88.2 percent and 12.3 percent year-to-date, respectively.

Conclusion

Revenues exceeded monthly estimates as the tax filing extension has disrupted the normal pattern of collections and as additional economic stimulus payments and continued changes in consumer behavior have driven higher than normal sales tax growth. With the delay in income tax filing season, much of the revenue impact of refunds and payments is yet to be determined. Total growth may trend back down as remaining refunds are processed following the May 17th tax filing deadline and when final revenues are compared to accruals processed in June last year for delayed taxes.
