

Increase emergency services engagement in the community.


Safe Community

Goal 6: Safe Community

PROTECT ALL RESIDENTS AND VISITORS BY ENSURING THEIR SAFETY AND SECURITY THROUGH RESPONSIVE, PROFESSIONAL, AND ACCOUNTABLE EMERGENCY SERVICES.



STRATEGIES

- 1.) Improve response times to ensure reliable and effective emergency services.
 - a.) Analyze emergency services data to identify obstacles that are hindering response times.
 - b.) Research and implement industry best practices to increase effective emergency services response.
 - c.) Develop processes to track results and implement improved procedures.
 - d.) Develop a public dashboard to report out on public safety KPI's.
 - e.) Conduct an interdisciplinary threat assessment to identify current public safety threats of the community and resolve any gaps in response/resources.
- 2.) Increase emergency services engagement in the community.
 - a.) Conduct a public survey to better understand the public safety needs of the community.
 - b.) Conduct collaborative educational campaigns throughout the community to raise awareness about the importance of public safety and how to effectively use emergency services.
