












Storm Summary



- Storm related fatalities: 49
- Customers without power: 1,358,000
- Residential damage total: 6,351
 - Destroyed: 380
 - Major Damage: 2,151
 - Minor/Affected Damage: 3,820
- Shelters:
 - 22 locations
 - 402 citizens sheltered


Storm Summary (con't)




- Logistics requests: 1,018
- SC National Guard: 1,055 personnel
- Emergency Management Assistance Compact (EMAC)
 - Received assistance from 11 states (CO, DE, FL, MI, MN,MS, NJ, OR, LA, TX, and WA) ranging from search and rescue to engineer assets
 - Sent assistance to FL and NC (11 missions) ranging from rotary wing aircraft to search and rescue assets

Federal Assistance



- Individual Assistance
 - Approved assistance to over 214,000 citizens
 - Over \$225 million disbursed
- SBA
 - Approved loans for over 210 citizens
 - Over \$10 million approved

Federal Assistance (con't)



- Public Assistance
 - Current estimates at \$370M
- Hazard Mitigation Grant Program
 - Based on 15% of total federal costs
 - Currently estimated at over \$134M

- Mutual Aid
 - Counties provided assistance to other counties Emergency Management Assistance Compact (EMAC)
- Extensive planning, training and exercising at all levels of government
- Emergency management profession in SC is mature and experienced

Recommendations for Successful Local Emergency Management



- Build a strong working relationship between local officials and county emergency managers
- Consider offering the Senior Officials Emergency Management Course
- Encourage local agencies to participate in emergency management training and exercises
- Keeping legislators aware of the FEMA non-federal share requirement
